The construction of this proposed transmission line raises much concern for the health, safety and welfare of our residents. Not to mention the financial loss and displacement from their homes. We urge you to use extreme caution when you choose a corridor for this transmission line.

We feel the corridor should impact the least amount of residential property and persons. Our residents as well as the members of this board feel there is a serious safety issue involved and this proposal sends far too much power through a residential area.

Huntsburg Township Board of Trustees will attend meetings with Thompson and Montville trustees as well as Senator Grendell, Representatives Dolan and LaTourette and hopefully a representative from First Energy to find an alternate route that will offer the least amount of impact on a residential area.
